This letter seeks your participation as a member of the University Child Care Committee for 2022-2023. Brent Lloyd has agreed to chair the committee. Your help in advising our child care system at the University of Wisconsin-Madison is greatly appreciated.

The University Child Care Committee provides recommendations to the Provost and Director of the OCCFR regarding:

- the vision, mission and master plan for early childhood care and education at UW-Madison
- priorities for allocating space and facilities for early childhood care and education
- priorities for research and preservice training conducted in campus centers and opportunities to enhance engagement with researchers and instructors
- initiatives that advance the university's strategic priority of creating the best possible environment in which our people can carry out their responsibilities to the university
- implementation, coordination and evaluation of programs and services for children and families
- issues of access and affordability, especially pertaining to infant care services
- accountability of existing and proposed child care facilities, programs, and services for meeting the requirements of UW System FAPP G38, particularly related to the accreditation, affiliation, and mission of campus children's centers

## In 2022-2023, I understand that the committee will:

- continue to work with campus and network child care center directors to find ways to recover the financial loss caused by Covid-19 with the goal of enabling these centers to continue to serve UW-Madison families
- continue to focus on early educators' well-being: over the past three years, campus and network early educators have been reporting high levels of work-related stress and emotional fatigue. The increased demands on these teachers have also led to burn-out and teacher, director turnover and shortages.
- continue to build strong partnerships with high-quality early care and education programs in our community with the desired outcome of increasing participation in the UW-Madison Child Care Network and service to more campus families
- continue to review infant care expansion projects and vendor contracts (Waisman, Preschool of the Arts and Satellite Family Child Care)
- review the impact of child care services on the enrollment, persistence, and graduation of student parents
- continue to work with the Committee for Women in the University (CWU) to create a policy recommendation for providing additional child care facilities on campus.
- continue to explore flexible, part-time, back up and drop-in child care options for UW-Madison families

Some of you have been longstanding committee members with a deep commitment to campus child care and to the ongoing challenges of access, space, and affordability. Thank you for your continued support, ideas, and energy.
